

Official Order by the Van Alstyne City Council to repair, remove, or demolish Building in accordance with City of Van Alstyne Code Chapter 8, Article I – III and Chapter 214 of the Texas Local Government Code.

Property: 244 Tolson (G-0770 MCKINNEY JAMES & HRS A-G0770) In the City of Van Alstyne, County of Grayson, State of Texas.

Date of Order: May 10, 2016

On May 10, 2016, the Van Alstyne City Council held a public hearing regarding the above property. The Van Alstyne City Council declared the building located on the property to be an unsafe building and/or a hazard to the public health, safety and welfare in accordance the City of Van Alstyne Code Chapter 8, Article I – III and Chapter 214 of the Texas Local Government Code. Within <u>Sixty (60) days</u> of the Van Alstyne City Council's order, the property owner must repair, remove or demolish the building. If the ordered action is not taken within the time determined by the Council, the City of Van Alstyne will vacate, secure, remove or demolish the building. Violations on the property include the following:

- 1. Damage or deterioration exists to the extent that the building is unsafe.
- 2. Damage by fire, wind, or other cause has rendered the building or structure dangerous to life, safety, morals or the general health and welfare of the occupants or the people of the City.
- 3. The building or structure is so dilapidated, substandard, decayed, unsafe, unsanitary, or otherwise lacking in the amenities essential to decent living that the same is unfit for human habitation or is likely to cause sickness, disease, or injury or otherwise to constitute a detriment to the health of those persons assembled, working or living therein or is a hazard to the public health, safety, and welfare.
- 4. Parts of appendages of the building or structure are so detached that they are likely to fall and injure persons or property.
- 5. The building or structure does not meet the following International or National Codes or NCTOG recommended amendments as follows:
