Conduct a Public Hearing regarding a request by the owner/agent of the property situated in the City of Van Alstyne, County of Grayson, State of Texas, being described as GREERS 1ST ADDN, BLOCK 10, LOT E/2 1 located at 681 Nash Avenue and 558 Arizona Street, currently zoned Single Family Residential District – 1 (SF - 1) for a variance to the Van Alstyne Code of Ordinances, Section 46-73 (d) to reduce the front yard, side yard interior, side yard corner lot street side and rear yard setbacks for the structure at 681 Nash Avenue and reduce the front yard setback and minimum building size for the structure at 558 Arizona Street to allow for a replat into two lots with no modification to the existing structures.
