- 4. Citizens Communications. Laura Cooper of the Sister Grove Chapter of the Daughters of the American Revolution advised on Constitution Week being September 17th through 23rd and invited Mayor Riley to their September 5th meeting to issue a proclamation. Mrs. Cooper also advised of the Wreaths Across America event.
- 5. Presentation of Citizen Public Service Award by Police Chief Tim Barnes. Chief Barnes presented a Citizen Public Service Award to Craig White for placing himself in the line of danger and assisting an officer with apprehension of an impaired suspect.

- 10. Consider and take any action necessary regarding passage of an ordinance adopting the Parks Master Plan. Lee Thomas made a motion to approve the ordinance adopting the Parks Master Plan. Robert Jaska seconded the motion and the motion passed unanimously.
- 11. Consider and take any action necessary regarding authorizing advertisement for bids for road improvements to Kelly Lane paid from Kelly Lane escrow funds. Lane Jones proposed to widen and asphalt the road rather than chip seal because of heavy traffic. Katrina Arsenault made a motion to authorize advertisement for bids for road improvements to Kelly Lane paid from Kelly Lane escrow funds to asphalt. Ryan Neal seconded the motion and the motion passed unanimously.
- 12. City Manager's Report. City Manager Lane Jones provided a report detailing activities of the prior month.
- 13. Mayor and Council Closing Comments. Katrina Arsenault advised of Music in the Park on the 20th with a blood drive and the Popsicles in the Park event hosted by the Parks, EDC and CDC boards.
