1. Call to Order. Mayor Riley called the meeting to order at 6:30pm.

## **PUBLIC HEARINGS**

2. Conduct a Public Hearing to consider testimony on an ordinance amending the Zoning Ordinance, Subdivision Regulation Ordinance and Building Codes to cause said ordinances to be in compliance with House Bill 2439, House Bill 3167 and House Bill 2497, which bills take effect on September 1, 2019. The Public Hearing opened at 6:31pm. City Attorney Julie Fort provided a brief overview of House Bill 2439. John Spies suggested getting to know your legislators due to recent anti-city bills and expressed a belief that court cases will more clearly define the grey areas of the bill. Dr. Spies also suggested increases impact and other fees to use as a negotiating tool. Jim DuBois asked if any cities have filed suit against the state to which Mrs. Fort advised she is not aware of any. Mrs. Fort detailed House Bills 3167 and 2497 and possible options to alleviate confusion and hardship. There being no further public comment, the hearing closed at 7:33pm.
