AGENDA

- 1. Call to Order. Mayor Riley called the meeting to order at 6:45pm.
- 2. Citizens Communications. Mary Jane Farmer with the Van Alstyne Leader advised that deadlines for the publication have changed causing reports on the City Council meetings to be published ten days late. Mrs. Farmer advised that the Police Department's National Night Out as wonderful and asked that the speaker behind the projector screen be moved, encouraged the use of microphones and asked that public speakers be shown how to use the microphones. Trent Voigt detailed concerns brought forth by Security Title. Mr. Voigt advised that a title the EDC was given had millions of dollars in liens and Security Title suggested a fraudulent transaction which he refused to participate in.

- 3. Conduct a Public Hearing to consider testimony on a request by the owner/agent to rezone from Single Family Residential District 2 (SF 2) to Two-Family (Duplex) Residential District (TF). The property is legally described as COLLEGE ADDN, BLOCK 16, LOT 101' OF E END OF 4 & 5, more commonly known as 518 Gilcrease St and generally located at the north west corner of Gilcrease St and Texana St. *The Public Hearing opened at 6:52pm. Carey Pitts expressed concern for duplex zoning because the area is saturated with it adding single family is preferred. There being no further public comment, the hearing closed at 6:55pm.*
- 4. Conduct a Public Hearing pursuant to Section 505.158 and/or Section 501.073 of the Texas Local Government Code regarding the expenditure of more than ten thousand dollars (\$10,000.00) by the Van Alstyne Community Development Corporation under a performance agreement with Coufal-Prater Equipment, LLC d/b/a United Ag & Turf. The Public Hearing opened at 6:55pm. Rodney Williams detailed the agreement. Concern was expressed for United Ag & Turf's ability to meet the timeline set forth by the agreement. There being no further public comment, the hearing closed at 6:59pm.
