- 8. Approval of Supplemental Agreement no. 2 with Pacheco Koch Consulting Engineers, Inc. involving schematic design service for the Van Alstyne Central Social District.
- 9. Passage of a resolution continuing Resolution No. 07-2020-01 and the Mayoral Declaration of a local state of disaster due to a public health emergency in response to the COVID-19 virus outbreak.
- 10. Passage of an ordinance amending Ordinance Nos. 854, 861 and 865 amending the City of Van Alstyne Fiscal Year 2020 Budget.

- 19. Consider and take any action necessary regarding ranking applicants for appointment to the Planning and Zoning Commission Place 1, 2, 4 and Alternate Place 2. Ryan Neal made a motion to appoint John Spies to Place 2, Mike Drynan to Place 1, Jim DuBois to Place 4 and Jordan Kelley to Alternate Place 2 of the Planning and Zoning Commission. Katrina Arsenault seconded the motion and the motion passed unanimously.

Consider and take any action necessary regarding award of a construction contract to PCI for Thompson Farms Offsite water and wastewater improvements beginning at City of Van Alstyne Water Well #5 located at 1350 W Van Alstyne Parkway and continuing west along FM 121 to White's Creek in the amount of \$1,288,237.00. Robert Jaska made a motion to award a construction contract to PCI for Thompson Farms Offsite as stated. Marla Butler seconded the motion and the motion passed with Robert Jaska, Marla Butler, Ryan Neal and Katrina Arsenault in favor and Lee Thomas recusing.
