The subject property is located at 1917 Peggys Cove, in the City of Van Alstyne, County of Grayson, State of Texas. The Public Hearing opened at 6:32pm. Jennifer Gould described the request. Mayor Atchison read written responses into record. There being no public comment the hearing closed at 6:34pm.

Lee Thomas seconded the motion and the motion passed unanimously.

Conduct a Public Hearing regarding a request by the owner/agent for a variance to the Van Alstyne Code of Ordinances, Chapter 32, Section 32-13 criteria for permissible signs, (12) pole sign, (c) maximum height to allow for a height of 70' being 30' above the maximum allowable height. The subject property is situated in the City of Van Alstyne, County of Grayson, State of Texas, legally described as J UMPRHRESS CENTER PHASE ONE REPLAT LT 1 BLK TWO REPLAT, BLOCK 2, LOT 1, ACRES 1.093. The subject property is more commonly known as 385 N Henry Hynds Expressway. The Public Hearing opened at 7:13pm. David Ritter clarified that four votes are required to pass the variance request. Luke Motley, representing the owner/agent, spoke to the

request, concern for statutory construction and the writing of the amending ordinance. There being no public comment the hearing closed at 7:24pm.
