- Consider and take action regarding passage of an ordinance canvassing the returns of the May 7, 2022 General Election.

- 2. Administer Oath of Office to newly elected officials and issue certificates of election. Jennifer Gould administered the Statement of Officer and Oath of Office to Ryan Neal, Place 1, Marla Butler, Place 2 and Dusty Williams, Place 3.
- 3. Consider and take action regarding passage of an ordinance canvassing the returns of the May 7, 2022 Special Election and declaring the Home Rule Charter adopted, directing the City Clerk to deposit a copy of the executed ordinance as an order into the City's official records. *Jennifer Gould provided the official canvass results.*

4. Consider and any action necessary authorizing the City Manager to sign an electric service agreement for the City of Van Alstyne, for a term of not less than twenty-four (24) or more than ninety-six (96) months.

Consider and take action on a resolution approving a resolution authorizing the issuance and sale of Van Alstyne Economic Development Corporation Sales Tax Revenue Bonds, Taxable New Series 2022; providing for the security for and payment of said Bonds; and enacting other provisions relating to the subject.
