3. CONSENT AGENDA

Items are considered self-explanatory and will be enacted with a single motion. No separate discussion of these items will occur unless so requested by at least one member of the Planning & Zoning Commission.

- a. Approval of minutes from April 19, 2023 regular meeting.
- b. Approve a final plat for Saddle Brook, Phase 5, being a 81.2-acre tract of land located on the south side of FM 121, west of Durning Road, in the City of Van Alstyne's extraterritorial jurisdiction (ETJ).
- c. Approve a final plat for Churchill, Phase 3A-1, being a 10.7-acre tract of land located north of CR 429, east of CR 830, in the City of Van Alstyne's extraterritorial jurisdiction (ETJ).
- d. Approve a final plat for the Torres Addition, being a 7.5-acre tract of land located on the south side of Knob Hill Road, east of Homer Smith Road, in the City of Van Alstyne's extraterritorial jurisdiction (ETJ).
- e. Approve a final plat for the Sterling Meadows Addition, being a 17.7-acre tract of land located on the southeast corner of Knob Hill Road and Old Highway 6, in the City of Van Alstyne's extraterritorial jurisdiction (ETJ).
- f. Approve a final plat for River Ranch, being a 37.7-acre tract of land located on the north side of Spence Road, west of Waco Street (SH5).
- g. Approve a preliminary plat for Hidden Creek Estates, being a 42.4-acre tract of land located on the east side of Majors Road, north of FM 121, in the City of Van Alstyne's extraterritorial jurisdiction (ETJ).
- h. Approve a preliminary plat for Mantua Point, Phase 3A, being a 64.7-acre tract of land located on the northwest corner of Collin McKinney Parkway and Cartwright Road, in the City of Van Alstyne's extraterritorial jurisdiction (ETJ).

Consider and act upon a final plat for the CSWL Addition, and make a recommendation to City Council regarding a subdivision waiver for Elmont Storage regarding paving regulations, being a 12.9-acre tract of land located on the south side of FM 121, east of FM 3356, in the City of Van Alstyne's extraterritorial jurisdiction (ETJ).

Conduct a Public Hearing, consider, and make a recommendation to City Council regarding a request for a Specific Use Permit (SUP), to allow a church, rectory, or place of worship in a Single-Family Residential District-1 (SF-1), to allow for development of a fellowship hall at Fellowship Church of Van Alstyne, on 0.7 acres, located on the northwest corner of Marshall Drive and Dallas Avenue.
