### 3. CONSENT AGENDA

Items are considered self-explanatory and will be enacted with a single motion. No separate discussion of these items will occur unless so requested by at least one member of the Planning & Zoning Commission.

- a. Approve minutes from the May 17, 2023 regular meeting.
- b. Approve a final plat for Churchill, Phase 3A-2, being a 14.2-acre tract of land located north of CR 429, east of CR 830, in the City of Van Alstyne's extraterritorial jurisdiction (ETJ).
- c. Approve a preliminary plat for Deer Crossing, Phases 2-4, being a 73.5-acre tract of land located on the northwest corner of Burke Road and Muncy Road, in the City of Van Alstyne's extraterritorial jurisdiction (ETJ)
- d. Approve a final plat for Hidden Creek Estates, being a 42.4-acre tract of land located on the east side of Majors Road, north of FM 121, in the City of Van Alstyne's extraterritorial jurisdiction (ETJ).
- e. Approve a final plat for the LeBleu Heights, being a 7.9-acre tract of land located on the southwest corner of Pitchfork Road, north of Knob Hill Road, in the City of Van Alstyne's extraterritorial jurisdiction (ETJ).
- f. Approve a preliminary plat for Oaklawn, being a 255.6-acre tract of land located on the north side of FM 3133, west of Jim Cannon Road, in the City of Van Alstyne's extraterritorial jurisdiction (ETJ).

#### 4. PUBLIC HEARINGS/REGULAR AGENDA (NON-CONSENT)

a. Conduct a Public Hearing, consider, and make a recommendation to City Council regarding a request to rezone an approximate 2.5-acre tract of land from Agricultural District (A), (subject to the associated voluntary annexation petition, A-23-002), to Commercial District-General (C-2), located on the north side of County Road 377, east of SH 5 (Waco Street).

- b. Conduct a Public Hearing, consider, and make a recommendation to City Council regarding a request for a Specific Use Permit (SUP), to allow for a child care center in a single-family residential district, in order to allow for a day care (Uptown Kids Childcare and Learning Center) to operate in an existing church facility (Van Alstyne Church of Christ), on approximately 2.4 acres, generally located on the southeast corner of Rigsby Street and Hopson Street.
- c. Receive presentation regarding a prospective development and related concepts, for property generally located at the southeast corner of FM 121 (Jefferson Street) and the future extension of Lincoln Park Road.
- d. Staff Comments. Discuss recent actions taken by the City Council.
