## NOTICE OF PUBLIC HEARING ON TAX INCREASE

A tax rate of \$0.553713 per \$100 valuation has been proposed by the governing body of CITY OF VAN ALSTYNE.

PROPOSED TAX RATE \$0.553713 per \$100 NO-NEW-REVENUE TAX RATE \$0.454518 per \$100 VOTER-APPROVAL TAX RATE \$0.543104 per \$100 DE MINIMIS RATE \$0.583771 per \$100

The no-new-revenue tax rate is the tax rate for the 2023 tax year that will raise the same amount of property tax revenue for CITY OF VAN ALSTYNE from the same properties in both the 2022 tax year and the 2023 tax year.

The voter-approval rate is the highest tax rate that CITY OF VAN ALSTYNE may adopt without holding an election to seek voter approval of the rate, unless the de minimis rate for CITY OF VAN ALSTYNE exceeds the voter-approval rate for CITY OF VAN ALSTYNE.

The de minimis rate is the rate equal to the sum of the no-new-revenue maintenance and operations rate for CITY OF VAN ALSTYNE, the rate that will raise \$500,000, and the current debt rate for CITY OF VAN ALSTYNE.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that CITY OF VAN ALSTYNE is proposing to increase property taxes for the 2023 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON August 21, 2023 AT 06:30 PM AT Van Alstyne City Hall; 152 N Main Drive, Van Alstyne, Texas..

The proposed tax rate is greater than the voter-approval tax rate but not greater than the de minimis rate and does not exceed the rate that allows voters to petition for an election under Section 26.075, Tax Code. If CITY OF VAN ALSTYNE adopts the proposed tax rate, the CITY OF VAN ALSTYNE is not required to hold an election so that voters may accept or reject the proposed tax rate and the qualified voters of the CITY OF VAN ALSTYNE may not petition the CITY OF VAN ALSTYNE to require an election to be held to determine whether to reduce the proposed tax rate.

YOUR TAXES OWED UNDER ANY OF THE RATES MENTIONED ABOVE CAN BE CALCULATED AS FOLLOWS:
